As I write this letter for the Fiscal Year 2021-2022 Annual Report, I'm heartened by all we were able to accomplish in the face of many challenges. The pandemic was with us throughout the year, just as the experts had been predicting, and COVID continued to impact how business was conducted locally and around the world. For the entirety of Fiscal Year 2021-22--under the guidance of the Connecticut Department of Public Health and the Department of Developmental Services--LARC staff and the individuals in our programs maintained safety precautions. Then as now, we continue to wear masks, test if symptomatic, and isolate if positive for COVID. Keeping staff and the individuals in our care safe and engaged was and continues to be our top priority!



We continued to move forward with initiatives that would strengthen the Arc of Litchfield County (LARC) and we succeeded in achieving much of what we set out to do. We held the first live fundraising event since 2019. *Nature is Nurture* brought friends and neighbors together to eat, drink, bid, and learn about the health benefits of spending time amidst the trees. The Torrington Riverfront project was launched at the beginning of the fiscal year and by the end of it, the project team was working with families and guardians to solidify plans for moving day. The agency's new nursing program evolved throughout the year, and the Autism Resource Center opened its doors to the first pre-K playgroup. Our Day and Vocational programs continue to rebound to pre-COVID levels, and our Residential program remains strong and focused on growth as well. All are core programs of our agency. Through it all, staff continued to work diligently to better serve the individuals in our care.

Please take some time to read this report, which provides financials and other important information from the period between July 1, 2021 to June 30, 2022. The mission of LARC is to work cooperatively with others in developing opportunities for individuals with Intellectual/Developmental disabilities, including Autism, to reach their maximum level of independence; experience presence and participation; make decisions about their lives and their futures; and live with respect and dignity.

## OUR PROGRAMS & SERVICES

- **Vocational Program**

LARC's Vocational Program provides two types of opportunities for individuals interested in joining the workforce:

**Individualized Supportive Employment:**

LARC matches individuals with specific jobs after assessing the individual's skills and abilities. LARC provides training and ongoing support to the employed individual. Twenty-two (22) individuals were kept busy working throughout Northwest Connecticut in Fiscal Year (FY) 2021-2022.

**Group Placements:**

LARC also provides customized workgroups for employers requiring large amounts of manufacturing. Groups can remain on LARC payroll. Permanent supervision is provided for group placements. Forty-five (45) individuals were working as part of customized workgroups in FY 2021-2022.

- **Day Support Option**

The Day Support Program (DSO) provides stimulating activities for 40 individuals. Some of the opportunities provided are morning and afternoon social coffee hours, gentle stretching and chair yoga, music and art therapy, current event discussions, bingo, weekly sing along with a professional musician, and a variety of educational and arts & crafts activities. Walks at the Torrington Armory or on nature trails, visits to local parks, and other excursions provide socialization and exercise. Individuals also perform in concerts throughout the year in celebration of a variety of holidays including Christmas and 4th of July.





- **Residential Program**

The Residential program offers several options, all of which strive to provide supports and services that provide opportunities to live as independently as possible. LARC supports individuals by offering a variety of living arrangements:

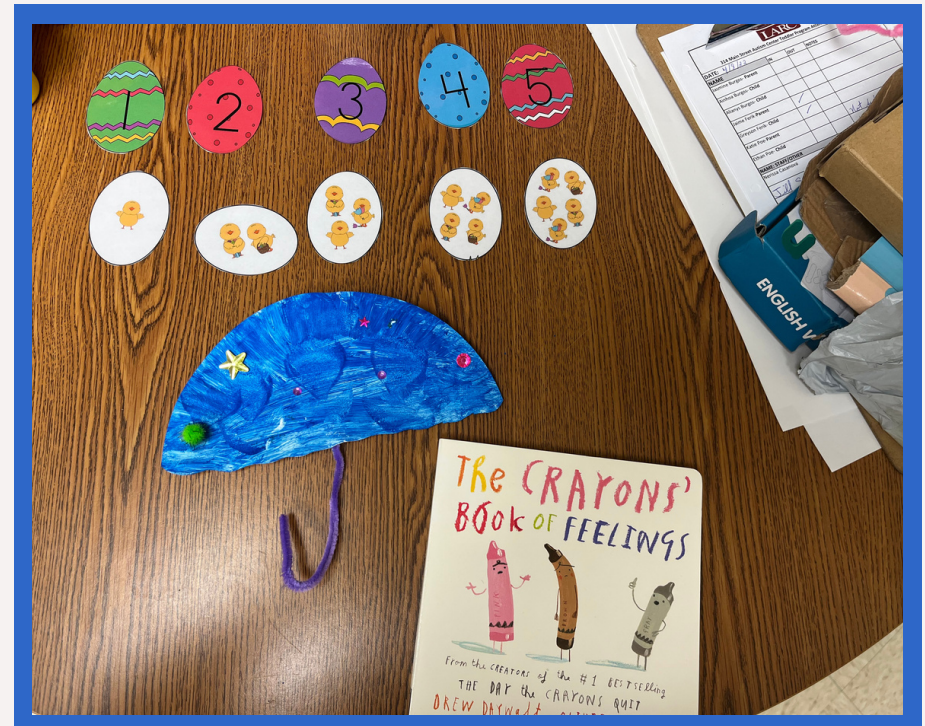
**Community Living Arrangements (CLAs)** - LARC owns and manages 5 CLAs where a total of 25 individuals reside.

**Individualized Home Supports (IHS)** - LARC offers In-Family Home Support and In-Own Home Support.

**Continuous Residential Supports (CRS)**- CRS provide 24-hour support in 3-person homes.

- **Autism Resource Center**

LARC's Autism Resource Center serves children with Autism Spectrum Disorder (ASD) and their families. The goal of the center is to prepare individuals with the disorder to live fully in the community. The center provides free monthly webinars covering topics important to parents, educators, providers, and guardians. A weekly playgroup for children aged 2-5 provides socialization and activities. The Time Away sensory garden provides a place of respite where parents and children can relax and enjoy the sites, smells and sounds emanating from the array of plants in the gardens.



- **Project SEARCH**

The Project SEARCH Program is a unique, business led, nine-month internship program for students with developmental disabilities. Interns in the program will complete three rotations at Charlotte Hungerford Hospital with the main goal of gaining the necessary skills to obtain competitive employment.

The goal of each student participant is competitive employment. The program provides real-life experience combined with training in employability and independent living skills to help youths with disabilities make successful transitions from school to productive adult life. The Project SEARCH model involves an extensive period of training and career exploration, innovative adaptations, long-term job coaching, and continuous feedback from teachers, job coaches, and employers. As a result, at the completion of the training program, students with intellectual disabilities can be employed in nontraditional, complex and rewarding jobs.

- **Recreation & Social Enrichment**

Recreational opportunities, ranging from movie nights to bowling leagues and craft clubs, provide social enrichment and are important for all individuals. Numerous recreational and social activities are offered to youth and adults alike with over 80 participants.

LARC's Special Olympics team consists of [64] athletes that compete in Bocce, Bowling, Alpine skiing, Cross Country skiing, and Track & Field.





- **Advocacy**

LARC is committed to protecting the rights of individuals with Intellectual and Developmental disabilities (I/DD) within our community. Along with our partners National Arc and Arc Connecticut, LARC provides opportunities throughout the year to participate in advocacy initiatives and a variety of workshops to educate families and the community about the rights of individuals with I/DD.



## UPDATES AND NEW INITIATIVES

- **LARC Logo Rebrand**

In late 2021, the agency undertook steps to re-brand with a new logo in order to more closely align the Arc of Litchfield County with the Arc National brand. The re-branding rolled out in spring 2022. A new sign was installed in May and the logo is now on letterhead, LARC's website, and all printed materials.

The new logo features the same elements of National Arc's logo, which is a visible manifestation of LARC's long relationship with The Arc. The Arc is the largest national community-based organization advocating for and serving people with intellectual and developmental disabilities and their families. As a national organization, The Arc has an immense presence in Washington and helped achieve many important milestones over the years.



- **Torrington Riverfront**

The Arc of Litchfield County has been working on making possible a new living arrangement for 12 individuals who are affiliated with the agency at the Torrington Riverfront Apartments situated along the Naugatuck River in downtown Torrington. This state-of-the art facility was completed last year and preparations began in earnest in 2021 with the LARC team managing the referral process, maintaining communications with DDS (Department of Developmental Services) and families, and implementing the housing application process. The team worked with the developer and management company, as well as state and city officials to ensure everything that needed to be accomplished by specific dates was, indeed, accomplished! As the second half of the fiscal year came to an end, the project was well on its way to fruition and individuals slated to move in were packing, buying furniture, and becoming familiar with their new state-of-the art home along the Naugatuck River.

- **Autism Resource Center**

The Autism Resource Center launched a new and much-anticipated playgroup in the fall of 2021. Children aged 2-5 with Autism Spectrum Disorder were welcomed into a newly-designed space, which caters to their ages and needs. The children along with their parents, guardians, and support staff, meet weekly, and work on individual as well as shared goals, which provide additional opportunities to work on various skills in different settings, promoting generalization. To accommodate more families a 2nd group has been added to the schedule. The center now offers morning and an afternoon weekly groups. The playgroups have been a huge success.





- **Project SEARCH**

Project SEARCH resumed in person at Charlotte Hungerford Hospital in September 2021. Kathy Riberdy, Special Educator and Project SEARCH Coordinator, was joined by four exceptional young adults who showed up ready to learn and work on job skills. Marianne Sedgwick, LARC Vocational Coordinator, and Ellen Kirsch, Skills Trainer, were welcomed additions to the Project SEARCH team. Interns worked on creating resumes, filling out applications, interview skills, looking professional, resolving conflict and internet safety among other topics. Charlotte Hungerford Hospital has been a welcoming and supportive host. Project SEARCH interns have learned valuable, transferrable skills by supporting eight departments including Nutritional Services, Podiatry, Cardiology and the Storeroom. One intern has been hired as a part-time office assistant in Podiatry at CHH. Another intern secured part-time employment working in the kitchen and housekeeping at Keystone Place in Torrington.

- **New Medication Certification Process**

A new medication administration certification process was introduced and fully implemented in July, with Phase 1 and Phase 2 components. Phase 1 is uniform across the Department of Public Health, Department of Children and Family Services, and Department of Developmental Services and includes the option to complete independently online.

- **Recreation and Special Olympics**

LARC participated at the Special Olympic Bocce competition at Scalzi Park in Stamford. Athletes won several medals including three golds, one silver, three bronze, and two 4th place ribbons. Some competitions were so close that two teams had to play two other teams for a run off. The team with the most points in the combined rounds won the gold. One division resulted in a tie for gold (LARC and another team ) because the runoff also resulted in a tie!! LARC had two athletes compete in the snowshoe competition and four in cross country skiing. Three athletes competed in alpine skiing.

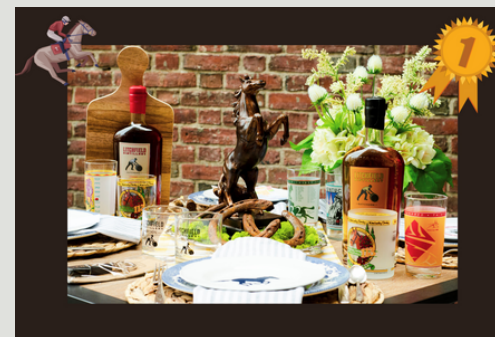
