INDIVIDUALS WHO LIVE IN INDEPENDENTLY LEASED APARTMENTS ARE ALSO SUPPORTED BY LARC, WITH A NEW THREE-BEDROOM SUPPORTED LIVING APARTMENT RECENTLY OPENING IN TORRINGTON. LARC ALSO PROVIDES IN-HOME SUPPORTS. THE MAJORITY OF THESE INDIVIDUALS HAVE ELDERLY FAMILIES/GUARDIANS THAT ARE UNABLE TO DRIVE. WITHOUT OUR PROGRAM, THEY WOULD BE STUCK AT HOME WITH LITTLE OPPORTUNITY TO GET OUT INTO THE COMMUNITY. A TOTAL OF 42 INDIVIDUALS ARE SERVED IN LARC'S RESIDENTIAL PROGRAMS.

VOCATIONAL DAY PROGRAM: APPROXIMATELY 115 INDIVIDUALS ARE WORKING THROUGH LARC'S VOCATIONAL PROGRAM WHICH PROVIDES INDIVIDUALIZED EMPLOYMENT PROGRAMS, JOB DEVELOPMENT, PLACEMENT, ON-THE-JOB TRAINING AND CONTINUOUS SUPPORTS TO INDIVIDUALS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES. LARC IS PROVIDING GROUP SUPPORTED EMPLOYMENT AT 12 SITES EMPLOYING 80 INDIVIDUALS.
